Agreements, Disputes and Unmarried Families

Pre and post-nuptial agreements

It's becoming common for couples getting married to make agreements about what will happen to their assets if their relationship breaks down. A pre or post-nuptial agreement helps provide certainty about how finances and property would be dealt with on divorce.

As specialist family lawyers, we can prepare these agreements and, if necessary, negotiate their terms to ensure that your best interests are protected at all times.

Dispute resolution

Lawyers are often associated with going to court, but that isn't the only option for resolving family issues. With experience and expertise in all forms of family dispute resolution, we can help you resolve your problems without standing in front of a judge.

As well as being expert litigators we're skilled negotiators. We work with mediators when it's appropriate, and several members of our team are also specialist collaborative lawyers.

Members of our team are also qualified in arbitration, a method which is relatively new to family law, but offers significant advantages, particularly in high-profile cases where maintaining privacy is key.

Unmarried families

It's still a widely-held belief that unmarried partners who live together hold the status of a common-law wife or husband, giving them the same legal rights and obligations on separation as if they were married. This isn't true.

Unmarried couples who live or have children together, can face difficult legal challenges if they later decide to separate.

We can provide you with specialist legal advice and services to help protect your position in ongoing relationships and on relationship breakdown. That includes advising on living together agreements, the extent of ownership in property, and whether either party may have potential claims over the other's property.

Alison's Story

Under our guidance, Alison Sharland asked the Supreme Court to set aside her divorce settlement on the basis that her husband had been dishonest to her and the courts during the original hearings.

We believed that Alison was misled into accepting a smaller settlement than she may have been entitled to. We worked through the complexities and challenges that Alison faced to see this case through to success.

Alison's case was heard at a three-day hearing. All Supreme Court judges unanimously ruled in her favour.

Her husband denied the dishonesty and hid behind highly technical arguments to avoid the consequences. However, the Supreme Court saw through those arguments to expose the true picture.

Ros Bever, our National Head of Family Law, said "It's the first time in a generation that the highest court in the land heard a case on the issue of non-disclosure in divorce proceedings.

We're pleased that the judges have taken the opportunity to state clearly that spouses can't mislead the courts, and it sends out a clear message that dishonesty won't be tolerated."

International Family Law

Family law is complex, and can also vary greatly from country to country even within Europe. Seeking specialist legal advice quickly is critical to helping to secure a successful outcome and to safeguard your interests.

With a wealth of experience advising on international issues arising in a variety of contexts, we can help you resolve all overseas family law issues. This includes divorce and financial claims necessary to divorce, child relocation, child abduction and international surrogacy arrangements.

Divorce and separation

The process of filing for divorce has recently become simpler, with the introduction of a new ‘no fault system’ which aims to make the process more straight forward and less acrimonious.

Choosing or having the wrong jurisdiction imposed on you for a divorce can have a serious impact on the outcome of your case.

Jurisdiction disputes

Securing the jurisdiction where the divorce should be filed can become complicated if you have close connections to more than one country. For example, if you were born or married in another country, or have lived there during your marriage, you may potentially be able to divorce there. We can advise on which jurisdiction would offer you the most favourable outcome.

Anti-suit injunction

We can act to prevent the other party from pursuing a divorce in another country so that you can proceed with the divorce in the jurisdiction that best protects your interests.

Confidentiality

To ensure the financial aspects of the divorce and the divorce itself are kept confidential, we can secure a non-disclosure agreement to prevent anyone talking to the press or other parties.

International treaties

England and Wales are signatories to various international conventions. This guarantees respect for our laws in certain other countries. We work with a wide network of foreign lawyers to ensure these treaties operate to protect our clients.

Interaction with concurrent foreign proceedings

Even if you’re divorcing abroad, you may still need specialist family law advice on how the financial aspects of the divorce would be dealt with in England and Wales, as it may be possible to pursue claims in this jurisdiction after a foreign divorce. You may also want advice on what would happen if your children come to live here.

Financial aspects of divorce

Often the first issue in an international case is to secure jurisdiction and ensure that the case is heard in the most appropriate country. This can have a significant impact on the financial award or settlement.

To secure the court’s jurisdiction requires swift action to protect your interests. Court proceedings may need to be issued as a matter of urgency. Our lawyers will be able to help you understand the process of separating assets in different countries and territories.

Freezing injunction

It’s increasingly common to encounter suspicious activity by the other party such as the disposal or hiding of assets during the divorce proceedings. We’ve had notable success in finding and freezing undisclosed assets both in this country and abroad in order to ensure a fair outcome.

International tax issues

It’s essential when dealing with foreign property and assets to consider the tax consequences and, if tax needs to be paid, where this money will come from.

Mirror orders

If you’re dealing with the transfer or sale of foreign property on a divorce, it’s often advisable to obtain a court order both in England and Wales (if the divorce is taking place here), and also in the country where the foreign property is situated.

Pre-nuptial agreement

If you or your finances have links with another country, or you have foreign property, choosing which jurisdiction will apply in your pre-nuptial agreement is essential. We'll liaise with our extensive network of foreign lawyers to ensure the agreement will have your desired effect, in England and Wales, and abroad. Our family specialists have drafted pre-nuptial agreements involving numerous jurisdictions with hundreds of millions of pounds of assets.

Children

We understand that situations involving children can often cause great tension in the family. Whether this involves relocating a child, adoption, parental orders or even child abduction, cases involving children need a caring and sensitive approach, as well as the expertise needed to act quickly in times of urgency.

Fertility and parental orders

Parental orders are designed to resolve the issues of parenthood following surrogacy. A parental order confirms legal parental status for both of the intended parents, and releases the parental responsibilities of the surrogate.

International child abduction

Where a child is abducted or wrongfully retained abroad, this can be extremely distressing and requires an immediate response. We frequently deal with this specialist area, obtaining emergency orders from the High Court, and applying the relevant international conventions to secure a child's return.

We can also help clients who need to defend these applications, for example because the children doesn't want to return, or because there are issues regarding their safety.

Relocation

Many families have personal or business interests around the globe which require them to relocate abroad. For those whose relationship breaks down, the children are often caught in the middle. One parent may wish to take the child to live in another country. To do this they'll ordinarily need the consent of the other parent, or a court order giving permission.

We have extensive experience in acting for parents who want to relocate and those who oppose their child's relocation. We can also help to negotiate contact arrangements where relocation is going ahead.
